1. INTRODUCTION

The Board of Directors (the “**Board**”) of CSE Global Limited (“**CSE**” or the “**Company**”), together with its subsidiaries, the “**Group**”) refers to its previous announcement dated 8 November 2022 in relation to the proposed acquisition (“**Proposed Acquisition**”) of the entire issued and paid-up share capital of Logic Wireless Limited, Logic Wireless Pty Ltd, and Logic Wireless Europe Limited (“**Logic Wireless Entities**”).

2. COMPLETION

Further to the earlier announcement on 8 November 2022, the Board wishes to announce that all the conditions precedent for the Completion of the Proposed Acquisition have been fulfilled and/or waived in accordance with the terms of the sale and purchase agreement and the Proposed Acquisition has been completed today.

Following the completion of the Proposed Acquisition, Logic Wireless Entities have become indirect wholly-owned subsidiaries of the Company.
